Implementation of Section 48 and Section 49(6) of the Indian Veterinary Council Act, 1984 - Regarding

Sir/Madam.

With reference to the subject cited above, it is to inform that, as per the decision taken by the Executive Committee of the Veterinary Council of India in its meeting held on 29.04.2025, it was resolved that Section 48 of the Indian Veterinary Council Act, 1984 mandates renewal of registration every five years by registered veterinary practitioners with the respective State Veterinary Councils.

It was further decided that the Registrar of all State/UT Veterinary Councils should be advised to delete, by way of Gazette Notification, the names of veterinary practitioners who have not renewed their registration, in accordance with the provisions of Section 49(6) of the said Act.

In view of the above, the VCI has instructed the Council to take appropriate action for updating the State Veterinary Register in accordance with the provisions of the Indian Veterinary Council Act, 1984 and the relevant State Rules framed thereunder.

To avoid deletion of names due to non-renewal, the Veterinary Practitioners under your jurisdiction may be asked to renew their registration on or before 25th August, 2025. The default list is enclosed herewith for reference and awareness, along with letters under reference for your kind information. The Veterinarians may find their latest renewal status by visiting the website www.orissaveterinarycouncil.com.
